

#### Terms & Conditions -- IB Referral Bonus Promotion

(Rally Trade, Nigeria -- September 2025)

This Introducing Broker (IB) Referral Bonus Program ("**Promotion**") is offered by FRNG LTD ("**Rally Trade**", "**the Company**", "**we**", "**us**") under the following terms and conditions.

IMPORTANT NOTICE: THIS PROMOTION IS SUPPLEMENTAL TO THE RALLYTRADE PARTNER AGREEMENT. IT DOES NOT REPLACE ANY TERMS WITHIN THAT AGREEMENT. IN THE EVENT OF ANY CONFLICT OR INCONSISTENCY BETWEEN THESE PROMOTIONAL TERMS AND THE STANDARD PARTNER AGREEMENT, THE TERMS OF THE PARTNER AGREEMENT SHALL PREVAIL. ALL CAPITALIZED TERMS USED BUT NOT DEFINED HEREIN SHALL HAVE THE MEANINGS ASCRIBED TO THEM IN THE PARTNER AGREEMENT.

# 1. Eligibility & Relation to Partner Agreement

- 1.1. This Promotion is available only to active Introducing Brokers ("**IBs**") who are in good standing under the Rally Trade Partner Agreement.
- 1.2. All participating clients must complete full KYC verification before being considered eligible under this Promotion.
- 1.3. All participating IBs must also be KYC-verified.
- 1.4. The Promotion applies only to clients and IBs who are legally permitted to participate under applicable local laws.
- 1.5. All standard terms, including but not limited to rules on Client diversification (Partner Agreement Clause 4.12), hedged positions (Clause 4.13), commission caps per lot (Clause 4.19), and minimum trade duration (Clause 4.20), remain in full force and effect during this Promotion.

# 2. Purpose & Scope

- 2.1. This Promotion is designed to incentivize Introducing Brokers to register new clients and actively grow their business with Rally Trade.
- 2.2. The Company reserves the absolute right, at its sole discretion, to modify, suspend, or terminate this Promotion at any time without prior notice, including in the event of exceptional market, regulatory, or economic conditions.
- 2.3. The Company also reserves the right to withhold or deny IB rewards if it determines that









an IB has abused, manipulated, or misused this Promotion or violated the Partner Agreement.

#### 3. Promotion Period

This Promotion is valid for new client registrations that occur between **September 15, 2025**, and **December 31, 2025** (the "**Promotional Period**").

#### 4. Trading, Deposit & Eligibility Requirements

### **Client Requirements:**

- Each referred client must be **new** to Rally Trade. Existing clients or duplicate accounts (as defined in the Partner Agreement Clause 4.17) are strictly excluded.
- Each client must make a minimum deposit of USD 100 (or the NGN equivalent) to qualify. The conversion will use the USD/NGN interbank exchange rate as quoted by Rally Trade on the date of deposit.
- Each client must trade at least 5 standard lots during the Promotional Period.
- Clients must not engage in abusive trading strategies, including but not limited to arbitrage, hedge trading across accounts, or wash trades (simultaneous opposite positions on the same instrument) solely to generate volume. The Company's determination of abusive trading is final.

# **IB Requirements:**

- An IB must be categorized under Tier 1, Tier 2, or Tier 3 based on the number of **eligible** new clients to qualify for a bonus.
- Associated Parties: Clients who are immediate family members (spouse, domestic
  partner, parents, children, siblings) or reside at the same address as the IB shall not
  qualify as new clients for this Promotion and will not be counted towards the bonus.
   The Company may request proof of identity and address to verify this at its discretion.
- Only one bonus tier will be paid per qualified IB. IBs will be paid the bonus corresponding to the **highest tier** for which they qualify.

## 5. Reward Structure (Tiered Bonuses)

Rewards will be calculated based on the number of **new eligible client registrations** achieved by each IB during the Promotional Period.











- Tier 1: 5–10 Eligible New Clients
  - Bonus: A bonus of \$10 for each qualified client.
  - Example: 8 clients = \$80 bonus.
- ◆ Tier 2: 11–20 Eligible New Clients
  - Bonus: A bonus of \$15 for each qualified client.
  - Example: 15 clients = \$225 bonus.
- Tier 3: 21+ Eligible New Clients
  - Bonus: A bonus of \$24 for each qualified client capped at \$1,000.
  - Additional Perks:
    - o Ability to host up to 2 in-person events at Rally Trade's official premises.
    - A marketing budget of up to \$500 per event for pre-approved expenses (subject to a separate events policy).

**Note:** All bonuses are paid **in addition to standard IB commissions** earned under the Partner Agreement. Standard commissions are subject to all applicable terms, including caps per lot traded.

#### 6. Bonus Payment Terms

- 6.1. All bonuses shall be paid exclusively in Nigerian Naira (NGN), based on the USD/NGN interbank exchange rate quoted by Rally Trade on the date the bonus is processed.
- 6.2. Bonuses will be verified and credited to the IB's designated commission account within thirty (30) business days after the conclusion of the Promotional Period and after all client trading activity has been reconciled.
- 6.3. The IB is responsible for any direct or indirect taxes, contributions, or other fees payable to state or public authorities in accordance with the legal provisions in force.

# 7. Good Faith, Compliance & Indemnity

- 7.1. IBs agree to act in good faith and disclose any relevant information concerning their referred clients.
- 7.2. All IBs and clients participating in this Promotion must comply with Anti-Money Laundering (AML) and Counter-Terrorist Financing (CTF) regulations.
- 7.3. Any fraudulent, abusive, or suspicious activity will lead to immediate disqualification,











cancellation of all bonuses, possible account suspension, and termination of the Partner Agreement.

- 7.4. IBs may not engage in any activity that may harm or negatively affect the Company's reputation.
- 7.5. By participating, all clients and IBs indemnify and hold harmless the Company from any claims, damages, losses, or liabilities arising from their participation in this Promotion or any actions taken by the Company to protect its business, reputation, and the interests of its clients.

#### 8. Final Provisions

- 8.1. Participation in this Promotion constitutes full acceptance of these Terms & Conditions and confirms the participant's understanding that the standard Partner Agreement is the governing document.
- 8.2. In case of any dispute, the Company's decision shall be final and binding.
